Summary Sheet/General Information

- \$1.000 in legal fees incurred to update registration fees.
- Master Steve Large is being paid a small salary as the admin assistant and is dealing with a lot of the paperwork.

#### Actuals/Fiscal Year

- Projected budget and actuals were close. Expenses for our actuals were \$145.000 while our projected expenses was \$162.000.
- Tournament revenue was less in 2018 compared to 2017.
- Government spending and other revenue were similar to last year.
- Difference in awards and some money left over.
- Difference in rent (2017 = \$18.000) vs. (2018 = \$8.000).
- Membership fees.

#### Budget

- Less revenue advertising, referee honorariums, tournament costs.
- Underspending in participation based funding. We should use more money to promote our clubs and gain more students. Such as putting money towards Taekwondo BC getting involved with festivals, charity events etc...
- Athlete rewards remain at \$10.000
- Team Training cost = \$6.000
- Money has been invested in new equipment but will need to invest more.
